Pursuant to and for the purposes of Legislative Decree 196/2003 and Art. 14 EU Reg. 2016/679, please be informed that:

- a) Sviluppo Lavoro Italia S.p.A. is the data controller;
- b) personal data of the person concerned will be processed exclusively for the implementation of project activities financed with resources from the Asylum Migration and Integration Fund (AMIF) and the European Social Fund PLUS (ESF+). The same data will be made available for controls by the Authorities in charge, as well as for those falling within the competence of the Audit Authorities;
- c) where the aforementioned personal data fall within the categories referred to in Article 9 of the EU Regulation, all measures shall be taken to ensure their accuracy, integrity, confidentiality and minimisation, as well as to prevent their undue dissemination;
- d) the data will be processed and stored for the time necessary to allow the implementation of project activities referred to in letter b) above, as well as to comply with the controls provided for by the regulations in force.
